NOTICE OF NOMINATION FOR OFFICE MUNICIPAL ELECTIONS - 2010

NOTICE is hereby given to the Municipal Electors of the Township of McKellar that Nominations for the offices of Reeve and Councillor may be made by completing and filing, in the office of the Clerk, nominations in the prescribed form. Nominations for the office of School Board Trustee may be made by completing and filing nominations in the prescribed form as detailed below.

How to be Nominated:

- a) Obtain nomination papers from the Clerk;
- b) Bring completed nomination papers to the Clerk between 9:00 am and 2:00 p.m. on Nomination Day, Friday, September 10, 2010 or during normal office hours between January 4, 2010 and September 9, 2010 inclusive;
- c) A nomination filing fee of \$200 for the office of head of council or \$100 for all other offices, must be paid at the time of filing, payable to the municipality in cash, certified cheque or money order. The fee is refunded if the candidate is elected, receives two percent of the votes cast, or withdraws the nomination;
- d) Nomination papers may be filed in person or by an agent but not by fax;
- e) Nomination papers must be certified by the Clerk before such person becomes a certified candidate.

If an insufficient number of certified candidates have been nominated to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, September 15, 2010 between the hours of 9:00 a.m. and 2:00 p.m. and such additional nominations, if required, may be filed in the office of the Clerk.
