

NOTICE OF NOMINATION FOR OFFICE  
MUNICIPAL ELECTIONS – 2014

**NOTICE is hereby given to the Municipal Electors of the Township of the Archipelago, the Township of Carling, the Municipality of McDougall, the Township of McKellar, the Town of Parry Sound, the Township of Seguin, and the Municipality of Whitestone** that Nominations for the offices of Mayor, Reeve and Councillor may be made by completing and filing, in the office of the appropriate Clerk, nominations in the prescribed form.

Nominations for the office of School Board Trustee may be made by completing and filing nominations in the prescribed form. Please contact your local school board for further information.

**How to be Nominated:**

- a) Obtain nomination papers from the appropriate Clerk;
- b) Bring completed nomination papers to the Clerk between 9:00 a.m. and 2:00 p.m. on Nomination Day, Friday September 12, 2014 or during normal office hours between January 2, 2014 and September 11, 2014 inclusive;
- c) A nomination filing fee of \$200.00 for the office of head of council, or \$100.00 for all other offices, must be paid at the time of filing, payable to the municipality in cash, debit card, cheque or money order. The fee is refunded if the candidate is elected, receives two percent of the votes cast or withdraws the nomination;
- d) Nomination papers may be filed in person or by an agent but not by fax;
- e) Nomination papers must be certified by the Clerk before such person becomes a certified candidate.

If an insufficient number of certified candidates have been nominated to fill all positions available, nominations will be reopened for the vacant positions only on **Wednesday, September 17, 2014** between the hours of 9:00 a.m. and 2:00 p.m. and such additional nominations, if required, may be filed in the office of the Clerk.
