#### MOTION AND NOTICE OF MOTION:

Moved by Joyce Hopkins, Seconded by Elaine McMahon, that the Township of McKellar Recreation Committee authorize Linda to create and manage the 2014/2015 skating program. Rates are the same as 2013/2014 program at \$50 per child or \$90 per family. Linda is authorized to spend up to \$300. (14-40) Carried

Moved by Joyce Hopkins, Seconded by Linda Filion, that the Township of McKellar accept the yoga proposal of Jane Savile to offer a yoga program on Tuesday evenings, \$80 for 8 weeks, to commence in the New Year. (14-41) Carried.
